Sub: Selection of Eight (8) candidates for admission to First Year of Three Years Diploma in Handloom & Textile Technology (DHTT) Course to be conducted at IIHT, Jodhpur, for Academic Session 2019-20 based on merit of marks obtained in 10th Standard or equivalent exam.

1. **Availability and Submission of Forms:** Applications are invited, on prescribed application format, **from bona fide residents of National Capital Territory of Delhi only**, for selection of candidates for admission to First Year of Three Years Diploma in Handloom & Textile Technology (DHTT) Course at the Indian Institute of Handloom Technology, Jodhpur commencing from 16th July, 2019. The forms can be obtained between 30th May, 2019 to 17th June, 2019 up to 6 p.m. from the Handlooms and Textiles Section, 4th Floor at the above Office, or can be downloaded from <http://industries.delhi.gov.in>. Duly filled in **forms can be submitted latest by June 17, 2019 up to 6.00 p.m.** at the above Office of the Commissioner of Industries (Handloom & Textiles Section), GNCT Delhi.
2. Only selected candidates in order of merit will be informed directly by the Director, IIHT, Jodhpur in the first week of July, 2019 for counseling. No TA/DA will be paid to eligible candidates called for counseling at Jodhpur.
3. **Educational qualification :** To be eligible for admission to first year of Diploma Course in Handlooms & Textile Technology, the candidate should have passed **10th standard or equivalent** examination with **English** as a subject of study.

Note: CBSE has already introduced the system of grading in 10th Examination. As such candidate must endorse the proof of details of marks from CBSE with their Application Form to enable the Selection Committee to prepare merit list which is prepared on the basis of marks secured in 10th examination only.

4. **Age Limit:** The age limit for admission to first year of Diploma Course in Handlooms & Textile Technology for **all the categories except SC/ST should be between 15-23 years and for SC/ST candidates it should be between 15-25 years as on 01-July of the admission year.**
5. **No. of Seats for Admission:-** Total Seats for Admission are **08** (Eight) for candidates who have passed 10th class from schools in Delhi. The Reservation Policy for SC/ST/OBC as per existing policy of Govt. of NCT of Delhi will be followed. Minimum 20% of the total seats allotted to the States are reserved for candidates belonging to weavers community. Shortfall, if any, will be met out from the candidates other than weavers community. 10% seats have been reserved for Economically Weaker Section (EWS).
6. **Stipend:** Each student admitted into the course will be eligible for **Stipend** of Rs.1000/- per month in 1st and 2nd Semester, Rs.1100/- per month in 3rd & 4th Semester and Rs.1200/- per month in 5th & 6th Semester for the duration of course (tenable for 10 months from 16th July to 15th May). In addition to above, State Govt. of NCT of Delhi will give **Additional Stipend** @ Rs.400/- per month to all candidates for entire duration of three years sponsored by Delhi Govt. against Delhi State Quota Seats. In addition to this, Book/Project/Tour Allowance will be given to only 2nd and 3rd year students @ Rs.1000/- per annum.

- (i) **Educational Qualification:** To be eligible for admission to first year of Diploma Course in Handlooms & Textile Technology, the candidate should have passed **10th standard or equivalent** examination with **English** as a subject of study.
- (ii) **Age Limit:** The age limit for admission to first year of Diploma Course in Handlooms & Textile Technology for **all the categories except SC/ST should be between 15-23 years and for SC/ST candidates it should be between 15-25 years as on 01-July of 2019.**
- (iii) **Seats :** Total Number of Seats for admission from Delhi State are **8 (eight)**.
- (iv) **Reservation:** The Reservation Policy for SC/ST/OBC as per existing policy of Govt. of NCT of Delhi will be followed. Minimum 20% of the total seats allotted to the States are reserved for candidates belonging to weavers community. Shortfall, if any, will be met out from the candidates other than weavers community. 10% Seats have been reserved for Economically Weaker Section (EWS).

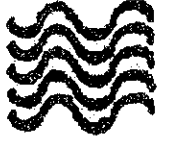
