Commissioner of Industries(Complaint Cell), Department of Industries, Govt. of NCT of Delhi, Udyog Sadan, IVth Floor, 419,FIE, Patparganj, Delhi. And it will be opened in the presence of all member of Purchase Committee.
2. Goods to be delivered at Office of the Commissioner of Industries, Govt. of NCT of Delhi, IVth Floor, Udyog Sadan, 419, F.I.E., Patparganj, Delhi.
3. Supplier should quote the rates inclusive of all taxes/ duties FOR destination.
4. The tenderer form must accompany with the Earnest Money @ 5 % of the value of the contract in favor of Commissioner of Industries, Govt. of Delhi which will be treated as performance security in case of successful Tenders.
5. Quotation should be clearly specified with specification and item should be marked with the **M.P.R. and also should be ISI mark or of reputed firms and should have proper one year warranty and guarantee** also dealer should submitte the sample of each item for which he had quoted rates so as to pass or reject the sample by the Chairman Purchase Committee.
